DIRECTIONS

1. These applications will be set down for hearing together in due course.
2. The applicants in the two cases must, on or before Friday, 5 September 2025, file a single paginated record in accordance with rule 20(1) and (2) of this Court's Rules, containing only those portions of the record that are strictly necessary for the determination of the issues.
3. The cost of preparing the consolidated record shall for the time being be borne by the applicants in the two cases in such manner as they may agree and, failing such agreement, as to one-half each.
4. Written argument, including argument on the merits of the appeal, must be lodged by—
 - (a) the applicants, on or before Friday, 19 September 2025;
 - (b) the respondents on or before Friday, 26 September 2025.
5. The applicants' submissions in each of the cases may not exceed 50 pages.
6. The respondents must file written submissions covering both cases, and such submissions may not exceed 60 pages.
7. The applicants may not file submissions in their capacities as respondents save with the leave of the Court upon application for directions to that effect.
8. Further directions may be issued.
